a. **COG Climate Action and Adaptation Plan (CAAP) Exercise:**

The goal of this exercise is for the Board to review the 82 CAAP actions and collectively discuss what actions should become part of the Township’s capital improvement process and strategic planning process. Hopefully, it helps to define some of the priorities for the Township related to the CAAP.

The COG is also interested in Patton’s feedback so that it can be shared with the CAAP Implementation Technical Advisory Group (TAG) to help inform the CAAP

Implementation Strategy. The TAG will be using the feedback along with their work on impacts of the action (and other stakeholder engagement) to help define the priorities for action.

A copy of the exercise in an Excel spreadsheet was emailed to the Board. A hard copy is also included with the agenda.

The exercise should be filled out ahead of the meeting. The Board will then discuss the responses to ensure consensus on each of the items listed. Once consensus is reached, the Manager will send the results back to Pam Adams at the COG.
