Note: Criminal Arrests are the number of people arrested, not the number of charges, counts or cases cleared. These include arrests made at the time of the incident as well as those filed after an extended investigation.

Department Notes:

- A 20-year-old female was charged with theft by unlawful taking and receiving stolen property. The woman found a purse in the parking lot of a township business. She removed approximately \$1,000 in cash then threw away the wallet and the rest of the contents.
- A 30-year-old female was charged with DUI and possession of methamphetamine. The woman was passed out and slumped over the steering wheel of her car in a township parking lot. She failed field sobriety tests and was placed in custody for DUI. K9 Graf was summoned to the scene, and he alerted on the vehicle. A search warrant was secured for the vehicle and several containers with methamphetamine were located.
- A 40-year-old male was charged with simple assault and harassment. The charges stemmed from a domestic dispute where the male threatened a family member with a knife.
- 13 arrests were made for retail theft, 1 for minor's law and 2 for driving under the influence.
- Officers successfully served 14 warrants of the 18 warrants that they attempted to serve.
- Officers conducted 50 vacation home checks.

Use of Force: PTPD officers used force during one incident in the month of February.

As an officer was breaking up a loud party, a resident directed his attention to a physical fight in a parking lot between two females. The officer gave verbal commands to stop fighting as he approached the women, but they ignored him and continued to fight. The officer had to physically pull the female on top, off of the female on the ground in order to break up the fight. No injuries were reported.

Community Relations

Ofc. Snyder and Graf did a K9 demonstration for a Girl Scout group.

Ofc. McCaslin conducted a ride-along for a township resident.

Sgt. Shupenko gave a presentation about first responders to a Boy Scout Pack.

Officers conducted foot patrol of college student complexes for "State Paddy's Day" and provided police presence for the Happy Valley Comic and Collectibles Convention.

Ofc. McCaslin gave a presentation about drugs and DUI for a Boy Scout Pack.

Ofc. Sunderland installed two child safety seats for a township resident.

Training and Department Activities

Ofc. Shaffer and Ofc. Tuskovich attended Tactical Response Team training.

Ofc. Snyder and K9 Graf completed their required 2 training days for the month.

Ofc. Shaffer completed Police Officer Supervisor In-Service training preparing him for his promotion to Sergeant.

Officers completed yearly in-service training. This year's topics included Legal Updates, Suicide by Cop, Community Relationships, Law Enforcement Ethics, Officer Wellness, Use of Force, and Critical Policy/Case Law Review.

Chief Jolley attended a Humane Officer meeting, Centre County Chiefs meeting, and the Community and Campus in Unity meeting.





Chief Jolley,

I wanted to extend a special thank you to the Patton Township Police Department and Officer Robert Carter. On the evening of July 13, 2023 Officer Carter was most helpful to me both on the phone and in person.

I, a 68-year-old mother, was at a loss as to what to do and where I should turn. I was house and pet-sitting while my daughter and son-in-law, who live in Patton Township, were out of the country.

I was taking out the trash and went to re-enter the home, much to my surprise, the door into the house would not open. The door locking mechanism had unexpectedly failed, and I got locked out of their home with all my means of communication and transportation (cell phone, car keys, house keys etc.) inside the home.

This was my totally helpless state. I realized there was no way I could get in and all my items were locked inside. The cell phone with everyone's phone numbers and the car keys to go home or get help were all inaccessible.

I had just met the new neighbor who recently moved into the neighborhood. They had no internet, poor cell phone reception, and no paper, pens, etc. for us to jot down phone numbers to try to help me connect with any locksmiths in the area. Even though multiple locksmith websites said they offer 24/7 service, their answering services said and quote open tomorrow at 8:00 a.m. The new neighbor was unable to offer a ride to me due to a guest coming. When that failed, we placed a call to Patton Twp. police for some advice on what to do next.

It was a full afternoon/evening of events that I just could not have made make up. Upon calling Patton Township non-emergency line I was put in-touch with Officer Carter who was very helpful, patience and kind enough to listen to my mishap and offered to pick me up and take me to Lemont where I would have my relatives help me when they arrived home.

The time and understanding Officer Carter gave me from start to finish was very professional in every way, but still caring and helpful in meeting my immediate needs. Wow - my unexpected first ride in a police cruiser and I'm so glad it was for non-criminal reasons.

Once my relative returned I was able to get home around 9:30 p.m. where I had a name and number of a locksmith in a neighboring town who was willing to come at 10:00 p.m. that evening and give assistance with the lock. But even that was not easy, the lock could not be picked and the core was difficult to drill out. Once that was done, he was able to see the slide/plate mechanism in the door hung up because it must have broken when the door closed so I did not lock myself out. By 11:00 p.m. I was back to some kind of normalcy.

When all was said and done, I had not locked myself out of the house and that made me feel better when I didn't think I had touched the lock. Just the same it was an experience that I can now look back on, shake my head and laugh. The couple arrived home to a new lockset and quite a story to go along with it.

A thank you to you and to Officer Carter on what may have seemed to be a small matter to the department but, was a lot more than that to me. What may have seemed unimportant to some meant everything to me on how this was handled.

Thank you and your department for always putting yourselves out there for the benefit of all without knowing what you'll be dealing with in this uncertain world we live in.

Sorry it took so long but, hope it brings a chuckle to both you and Officer Carter's day.

God's blessing to all those who give their lives for us daily. Be safe and know your work does not go unnoticed by many.
