Note: Criminal Arrests are the number of people arrested, not the number of charges, counts or cases cleared. These include arrests made at the time of the incident as well as those filed after an extended investigation.

Department Notes:

- A 22-year-old male was arrested and charged with simple assault and harassment. The male physically assaulted his fiancé during a domestic dispute.
- A 22-year-old male was arrested for public drunkenness and disorderly conduct. The male was passed out on a CATA bus and was found to be heavily intoxicated.
- A 52-year-old male was arrested for public drunkenness. Officers assigned to the concert at Beaver Stadium came across the male who had difficulty standing and walking due to the level of his intoxication. The male eventually had to be transported to the hospital for more advanced care.
- 2 arrests were made for retail theft, 1 for minor's law and 7 for driving under the influence.
- Officers successfully served 40 warrants of the 67 warrants that they attempted to serve.
- Officers conducted 15 vacation home checks.

Use of Force: PTPD officers did not use force during any incidents in the month of April.

Community Relations

Officers performed walk throughs of the Nittany Valley Sports Centre during events at the facility throughout the month.

Officers drove through our parks and spoke with residents during the solar eclipse.

Ofc. Snyder and Graf did a K9 Demo/meet and greet for the Township Open House during Local Government Week.

Ofc. Vardzel and Ofc. Sunderland attended a child safety seat check/installation event at Target.

Det. Sallade participated in a Camp Cadet recruitment event at the Park Forest Middle School.

Ofc. Vardzel participated in a child safety seat check/installation event with Centre County CYS at the YMCA.

Sgt. Albright participated in a drug takeback event at Wegmans. 15 pounds of unwanted/unused medications were collected.

Ofc. Sunderland installed a child safety car seat for a township resident.

Training and Department Activities

Sgt. Shaffer and Ofc. Tuskovich attended Tactical Response Team training.

Ofc. Snyder and K9 Graf completed their required 2 training days for the month. Graf was called out by PSP to assist at a traffic stop. Graf alerted on the vehicle. The vehicle was searched, and officers located 4 grams of methamphetamine.

Det. Sallade attended "New Detective" training.

All PTPD officers completed our MPOETC required firearms qualifications with all department owned weapons.

Ofc. Finochio and Ofc. Kauffman attended the Pennsylvania Narcotics Officers Association annual conference.

Ofc. Vardzel conducted a plain clothes detail, teaming up with loss prevention at a township store, in a proactive effort to curb retail theft. One stop was made. The individual was wanted in Argentina and the International Criminal Police Organization (INTERPOL) had issued a warrant for him. The individual had previously been deported from the U.S. and he had been flagged for removal as he is considered a violent felon. Ofc. Vardzel worked with the

Department of Justice, U.S. Immigration and Customs Enforcement, and INTERPOL to deport the individual. The individual was to be deported back to Argentina where he will answer to Armed Robbery charges which were filed there.

Hunter Brooks was hired by PTPD as a patrol officer. His first day with the department was on April 29th and he was officially sworn-in on May 2nd.

Chief Jolley attended a Humane Officer meeting, Centre County Chiefs meeting, Centre County Emergency Services meeting, Radio Reprograming meeting, Radio Advisory Committee meeting, and radio demonstrations by Motorola and Kenwood.

Patton Township Police Officers Recognized

Five police officers were recognized for their life-saving work at the February board of supervisors meeting in Patton Township, Centre County.

Officers Bradley Tuskovich and Sunchul Soohoo were awarded the Life Saving Award for reviving an unresponsive male. The officers began CPR and administered an AED, which shocked the patient two times. When EMS arrived and transported the patient to the hospital, he had a pulse and was breathing.

"About three weeks later, the patient's wife reached out and shared a photograph of the patient and his adult daughter," Patton Township Chief of Police Tyler Jolley says. "She said that without the officers' quick response, he would have likely not been in the picture at her birthday party a few weeks later. He made a full recovery because we could get to him so quickly."

Officers Jeffrey McElrath and Justin Sunderland also received the Life Saving Award by intervening when a 14-year-old boy was attempting to harm himself. The officers' quick action and empathy allowed the boy to receive the mental health care he needed.

"The officers showed an extreme amount of compassion and empathy for this juvenile and sat there and spoke to them for about a half an hour," Jolley says. "They created a great bond and let them know they matter."

Finally, Officer Vardzel was awarded the Police Commendation Award by uncovering a sex trafficking operation involving minors. Vardzel coordinated with the local FBI field office, State Police, and other local agencies to arrest the offending individuals.

Jolley and a fellow sergeant decided to start the award programs to recognize exceptional officers.

"We try to recognize our officers any time we feel that they go above and beyond the call of duty," Jolley says. "Police work is a difficult job, and we expect our officers to provide the highest level of public service to the residents of Patton Township. Three years ago, myself and one of my sergeants sat down and decided we needed to do a better job of recognizing officers when they do something exceptional."

The department has also developed a closer relationship with the community as a result of the award programs.

"The goal of the recognition is for the community to see a positive from the police department," Jolley says. "We're continuing to try to bridge the gap between the community and police and letting the community know that officers are often put in difficult situations, and in these occasions, these officers rose to the call."
