Note: Criminal Arrests are the number of people arrested, not the number of charges, counts or cases cleared. These include arrests made at the time of the incident as well as those filed after an extended investigation.

Department Notes:

- A 37-year-old female was arrested for writing a bad check. The female wrote a \$1,500 check from an account that did not have sufficient funds to cover the amount. The investigating officer gave the female multiple opportunities to correct the issue and avoid being charged, but she never did.
- A 22-year-old male was arrested for access device fraud and theft by deception. The male picked up an online purchase worth \$1,000 which he was not authorized to take. The male had fraudulently added himself to a customer's legitimate account. The investigating officer spoke with the actual owner of the account who confirmed he did not know the male and he was not authorized to make purchases on his account.
- A 37-year-old male was arrested for criminal mischief. On two occasions the male broke exterior windows at a township business, causing approximately \$4,000 worth of damage. A thorough investigation was done which included obtaining surveillance video, identifying the suspect, and getting a confession from the suspect.
- 4 arrests were made for retail theft and 1 for driving under the influence.
- Officers successfully served 8 warrants of the 15 warrants that they attempted to serve.
- Officers conducted 12 vacation home checks.

Use of Force: PTPD officers did not use force during any incidents in the month of June.

Community Relations

Officers toured the new Penn Highlands Hospital.

Ofc. Tuskovich did a site assessment of the Grays Woods Elementary School.

Ofc. Snyder and Graf visited Reliance Bank where employees were able to meet Graf and learn about how our agency utilizes his services.

Training and Department Activities

Sgt. Shaffer and Ofc. Tuskovich attended Tactical Response Team training.

Det. Federinko and Ofc. Tuskovich attended Pennsylvania Justice Network (JNET) training.

Ofc. Ottolini attended Crisis Intervention Team training.

Ofc. Ottolini attended a 3-day Emergency Vehicle Operation Course training.

Sgt. Shupenko attended SOLO officer response to active shooter incidents and structure clearing for patrol and small units training.

Ofc. Snyder and K9 Graf completed their required 2 training days for the month. Ofc. Snyder and Graf also completed a 3-day recertification course, which is required each year for K9 teams. Graf was called out twice in June, once to sniff a vehicle for narcotics and once to track a suspect in a criminal mischief case.

The Patton Township Police Department welcomed our newest officer, Michael Friend. Ofc. Friend was sworn-in on June 27th and is currently in our field training program.

Chief Jolley attended a Humane Officer meeting, the Happy Valley Business Association meeting, the Centre County Chiefs meeting, and the Crisis Intervention Team training graduation ceremony.
