Note: Criminal Arrests are the number of people arrested, not the number of charges, counts or cases cleared. These include arrests made at the time of the incident as well as those filed after an extended investigation.

Department Notes:

- A 24-year-old male was arrested for possessing drug paraphernalia. The male was stopped for speeding and upon making contact the officer smelled the odor of marijuana. The officer recovered paraphernalia from the vehicle which had previously been used to ingest marijuana.
- A 41-year-old male was arrested for strangulation, simple assault, and harassment. The charges stemmed from a domestic dispute between the male and his mother.
- A 66-year-old male was arrested for harassment. The male entered into a verbal altercation with a male unknown to him. The male, who was the aggressor, then proceeded to punch the individual in the head two times.
- 17 arrests were made for retail theft and 4 for driving under the influence.
- Officers successfully served 9 warrants of the 9 warrants that they attempted to serve.
- Officers conducted 6 vacation home checks.

SUBJ: Performance Report

On 7/2/24 Police Secretary Albright was conducting routine report reviews and checked a vehicle entry that had been included in a traffic stop report from the previous evening. While doing so, she found the vehicle was mentioned in a retail theft report from January 2024. There were surveillance photos of the suspect from that incident but he was never identified. Police Secretary Albright brought this to the attention of a detective and the officer who conducted the traffic stop, and they were able to confirm that the driver at the traffic stop was the theft suspect. The detective, after further investigation, filed criminal charges against the suspect.

It was due to the thorough work of Police Secretary Albright that a suspect from an inactive case was identified and held accountable for their actions. Her work reflects the highest credit on herself and the Patton Township Police Department.
