*Note: Criminal Arrests are the number of people arrested, not the number of charges, counts or cases cleared. These include arrests made at the time of the incident as well as those filed after an extended investigation.*

## **Department Notes:**

- A 34-year-old female was arrested for delivery of a controlled substance. The female was selling oxycodone pills.
- A 22-year-old male and a 27-year-old male were charged with felony forgery and theft by deception. The males used fraudulent identification to purchase over \$4,000 worth of merchandise from a township store. The males attempted to do the same thing in Blair County where they were arrested.
- A 37-year-old male was charged with misusing the 911 system. The male contacted the Centre County Emergency Communications Center (9-1-1) and made statements, none of which were related to reporting an emergency.
- 3 arrests were made for retail theft and 4 for driving under the influence.
- Officers successfully served 11 warrants of the 12 warrants that they attempted to serve.
- Officers conducted 11 vacation home checks.

**Use of Force:** PTPD officers did use force during one incident in the month of August.

Officers were dispatched to a residence for a disorder involving a male who was heavily intoxicated. Upon arrival, the male blocked the doorway as the reporting party attempted to come outside and speak with police. Officers grabbed the intoxicated male by his arms and led him outside the residence. The male was handcuffed without further incident. The male was transported to the hospital for treatment. Nobody on scene was injured. After investigation, the male was charged with DUI and harassment.

### **Community Relations**

Det. Sallade assisted with girl's week at Centre County Camp Cadet.

Ofc. Snyder and K9 Graf did a K9 demonstration for girl's week at Centre County Camp Cadet.

Ofc. Tuskovich assisted in conducting an active shooter drill for staff at The Village at Penn State.

Ofc. Tuskovich helped instruct school bus driver safety training for SCASD drivers. He also attended the staff back-to-school training for SCASD staff, gave his annual safety presentation to the staff at Park Forest Middle School, and attended the back-to-school night at PFMS.

Ofc. Tuskovich and Chief Jolley participated in the Grange Fair Parade.

Officers were very active conducting walk and talks at the college housing complexes along Vairo Blvd. and Toftrees Ave. They were also present in the box stores for PSU student move-in.

### **Training and Department Activities**

Sgt. Shaffer and Ofc. Tuskovich attended Tactical Response Team Training.

Ofc. Brahosky attended the three-day Emergency Vehicle Operation Course.

Ofc. Fiochio attended Emergency Vehicle Operation update training.

Ofc. Snyder and K9 Graf completed their two required training days for the month. In addition to their required training, they did a K9 sweep of a drug rehabilitation facility and were called out to sniff a vehicle on a traffic stop for SCPD. Ofc. Snyder and Graf participated in the annual TRT readiness exercise with a tracking scenario.

Chief Jolley attended the TRT readiness exercise, assisted with BPD interviews for police officer, attended a football planning meeting, attended a meeting with the OAG related to organized retail theft rings, attended the Community and Campus in Unity (CCU) meeting, and the Centre County Chiefs meeting.

Dear Chief Jolley,

Last Friday my husband passed away here at our townhouse [REDACTED]. When I found him unresponsive, I phoned 911 and 2 officers from Patton Township showed up almost immediately. As the rescue people worked to try to revive him in the living room, one officer stayed with me in the family room. He reassured me and I could tell he was protecting me from the rescue scene taking place in the living room. He talked with me, he distracted me, he was empathetic, he was kind and I felt he was honestly concerned for me. He really helped me at an terrible time. Later I was sorry I didn't get the 2 officers names. They were both so professional yet caring.

This afternoon as I was driving past Target I had a thought I wanted to send to my daughter as she prepares the eulogy for my husband so I pulled over into the large empty Target lot and started writing my idea on a card. First thing you know, I hear someone say "are you alright ma'am." I look up and it's a Patton Township police car and the officer said he was worried because he saw me parked and my head was bending down. I explained what I was doing and that's when he said "you look familiar." All of a sudden I said "you were in my house last week." It was one of officers who was there at the time of my husbands death--Officer Bahosky. Once more he made sure I was OK, we chatted like old friends and I thanked him profusely for his kindness last week. This time I got his name and just had to tell you what great young police officer you have on your force.




