Note: Criminal Arrests are the number of people arrested, not the number of charges, counts or cases cleared. These include arrests made at the time of the incident as well as those filed after an extended investigation.

Department Notes:

- A 27-year-old male was charged with access device fraud. The male found a credit card on the ground which belonged to someone else. The male then used the card at multiple locations. Officers eventually tracked the male down to a hotel in the township where he had purchased a room for the night with the stolen card.
- A 50-year-old female was charged with theft by deception and retail theft. The woman selected merchandise off the shelf at a township store. The female then made a fraudulent return of that merchandise which she never paid for. The female was given store credit and subsequently made purchases with the money she was “reimbursed” for the fraudulent return.
- A 37-year-old male was charged with forgery, attempted theft by deception and attempted bad checks. The male tried to pass a fraudulent check at a township bank for over \$2,000. The male had forged the name of an employee on the check.
- A 52-year-old male was arrested for theft by unlawful taking. The male was acting suspicious inside a township store. An employee had their phone sitting on the counter behind the cash register. When the employee was distracted, the male grabbed the phone and fled the store. Officers easily identified the male who they have dealt with for previous theft offenses.
- 15 arrests were made for retail theft and 4 for driving under the influence.

- Officers successfully served 3 warrants of the 6 warrants that they attempted to serve.
- Officers conducted 27 vacation home checks.

Use of Force: PTPD officers did use force during one incident in the month of October.

Officers were dispatched to a disorderly person call at a residence in the township. Upon arrival officers found a female, who did not reside there, who was heavily intoxicated. The residents, who had initially invited the female over, wanted the female removed from the residence. Due to her level of intoxication EMS was summoned to care for her. When EMS arrived and they tried to move the female to the ambulance, she began to become physically combative. Officers handcuffed the female for everyone's safety, but she continued to try and kick police and EMS workers. EMS eventually sedated the female on scene, and she was transported to the hospital for further treatment. No injuries were reported by anyone at the scene. The female was charged with disorderly conduct and underage drinking.

Community Relations

Ofc. Tuskovich attended a Trunk or Treat event at Park Forest United Methodist Church.

Ofc. Snyder and Graf did K9 demonstrations at the Citizen's Police Academy, a WPSU Fair, and at a Safety Fair at the Zion Community Church.



