## Department Notes:

- A 69-year-old female was charged with theft by deception. The victim in this case contacted PTPD and stated she paid the female over \$1,500 for a trip to Italy. The female who owns a tourism company never booked the entire trip. The victim found out when they arrived in Italy.
- A 21-year-old male was charged with theft and receiving stolen property. The male removed a decoration from a township store worth \$400. The male was identified by a detective and arrangements were made for the item to be returned to the store.
- 7 arrests were made for retail theft and 1 for driving under the influence.
- Officers successfully served 1 warrant of the 3 warrants that they attempted to serve.
- Officers conducted 29 vacation home checks.

**Use of Force:** PTPD officers used force during three incidents in the month of November.

Officers responded to a domestic dispute where a male was being violent, combative, and irate with his family. Officers were met at the front door by a family member who stated, "hurry he needs help." Officers observed another family member holding the male down. Officers separated the two and attempted to verbally deescalate the situation. The male grew increasingly agitated and eventually threw a glass jar at an officer and then lunged at him. The

male tried to knee the officer and headbutted him. Another officer on-scene deployed a taser into the male's back. Officers were able to handcuff the male. EMS arrived on-scene and sedated the male. He was transported to MNMC for treatment. It was found that the male had been using methamphetamine. He was arrested for aggravated assault on a Police Officer, simple assault, and harassment. No injuries were reported.

Officers were dispatched to Penn Highlands Hospital for an intoxicated disorderly female. The female was yelling vulgarities and being combative with staff. Officers attempted to verbally deescalate the female but were unsuccessful. As staff discussed restraining and sedating the female, she walked aggressively towards staff. Officers grabbed the female's arm and shoulder, escorting her away from the staff and to a bed. Staff sedated the female, and she eventually fell asleep. No injuries were reported.

Officers responded to a report that a student, who was experiencing a mental health episode, had walked away from an elementary school. The student was located and officers waited for the parents to arrive. Officers attempted to verbally coax the juvenile into his mother's vehicle. The student eventually jumped into the mother's car, but quickly tried to exit the other side. An officer stepped in front of him and held his upper body preventing him from exiting the vehicle. The male eventually was placed fully in the vehicle and his parents took him home. No injuries were reported.

### **Community Relations**

Ofc. Tuskovich visited the preschool classes at CenClear/IU10 at the Matternville School.

Ofc. Tuskovich gave presentations about drugs and alcohol to the seventh grade PFMS health classes.

Ofc. Tuskovich gave an active shooter presentation at the Good Shepherd Catholic Church.

Ofc. Tuskovich attended a social media presentation for parents at State High.

Officers were very active, providing a police presence, in the Township retail stores on Black Friday.

### **Training and Department Activities**

Sgt. Shaffer and Ofc. Tuskovich attended Tactical Response Team Training.

Ofc. Snyder and Graf completed their two required training days. Graf was also deployed to track individuals on 3 occasions. He was utilized to conduct a narcotics sweep at the Centre County Correctional Facility. Graf also assisted the Centre County Drug Task Force on a traffic

stop. He alerted on the vehicle and following a search, 6 grams of methamphetamine and various items of drug paraphernalia were located. Two arrests were made.

Chief Jolley attended a Big Brothers/Big Sisters Advisory Council meeting, a Humane Society Police Officer meeting, the Happy Valley Business Association meeting and the Community and Campus in Unity meeting.

SUBJ: Performance Report

On 11/1/24, Ofc Vardzel and Ofc Carter responded to a residence in Patton Township for a report of a male in cardiac arrest. Upon arrival, the two officers found that the patient was not breathing and had no pulse. The officers attached an AED to the victim and when it advised that no shock would be delivered, the two began CPR. Ofc Vardzel conducted chest compressions while Ofc Carter administered oxygen. The two officers conducted CPR until relieved by EMS. The patient eventually regained a pulse and was transported to the hospital for more advanced care.

It was due to the quick actions of Ofc Vardzel and Ofc Carter that a patient who was in cardiac arrest was revived to the point that he could be transported for further care. Their actions reflect the highest credit on themselves and the Patton Township Police Department.

Hello,

October 9th began as a normal day for our family. Then suddenly, we were in crisis mode. Officer Sunderland happened to be nearby Scotia Game lands when my son's best friend needed to call 911. Officer Sunderland arrived on scene shortly after. He selflessly worked to control my son, Jonah's bleeding until rescue arrived. He also called Life Flight to the scene. Once medics arrived. He sat behind my son holding him up and calming him until Life Flight arrived. During this time, he also contacted me several times to update me on what was occurring at the scene and shared my "I Love you!" message to my son before he was flown to Dubois Hospital. I am always grateful for first responders, but for the last 48 days I have thanked God for Officer Sunderland every day!

After surgery, 3 units of blood, and 6 days in the hospital, Jonah returned to school on 11/4 and was released from Physical Therapy on 11/12. He is grateful for Officer Sunderland's service as well as his presence that day!
