Note: Criminal Arrests are the number of people arrested, not the number of charges, counts or cases cleared. These include arrests made at the time of the incident as well as those filed after an extended investigation.

Department Notes:

- A 50-year-old male was arrested for stalking and loitering and prowling. The male was caught on camera looking into a residence on multiple occasions. On the night of the males' arrest, the victim called the police stating that the male was at his residence again looking inside a window. An officer quickly responded and apprehended the male, who admitted to looking into the residence several times.
- A 29-year-old female was arrested and charged with arrest prior to requisition. An officer stopped the female for speeding. The officer learned that the female had a felony warrant from another County for criminal mischief.
- Two 19-year-old males and a juvenile male were charged with trespassing. An officer checked on a township park after dark when the park was closed. The officer encountered the three and smelled burnt marijuana. The three males were cited for trespassing and the officer decided to destroy the small amount of marijuana and paraphernalia confiscated from one of the males.
- 7 arrests were made for retail theft, and 3 arrests were made for DUI.
- Officers successfully served 10 warrants of the 10 warrants that they attempted to serve.
- Officers conducted 16 vacation home checks.

Use of Force: PTPD officers did use force during one incident in the month of June.

Officers were dispatched to Penn Highlands Hospital for the report of a disorderly female in the emergency department. On scene, officers learned that the female was in crisis and hospital staff was working with a delegate to secure a mental health warrant. Once the warrant was obtained, hospital staff requested police assistance with getting the female into a room. Multiple verbal attempts were made to move the female into the room without force. Eventually officers had to escort the female into the room and onto the bed. The female physically resisted, kicking an officer in the chest, breaking his BWC. The female was restrained to the bed by staff. Eventually she was able to free a hand, and she punched a female staff member in the face. The female was again restrained by staff but was able to free her hand for a second time. Officers utilized handcuffs and the female was sedated by hospital staff. The female was charged with aggravated assault, disorderly conduct, and criminal mischief. There were no injuries reported by the officer who was kicked or by the female. The staff member who was punched did suffer a minor injury.

Community Relations

Ofc. Tuskovich, Ofc. Snyder, and Graf attended a Bark in the Park event at a State College Spikes game.

Ofc. Finochio spoke with employees at a township business about recognizing fraud, scams, and criminal activity as part of their employment.

Ofc. Kauffman, Ofc. Brahosky, and Ofc. Brooks all assisted the Bellefonte Police Department with the annual Bellefonte Cruise.

Training and Department Activities

Sgt. Shaffer and Ofc. Tuskovich attended Tactical Response Team Training.

Officers began their update training in Emergency Vehicle Operation.

Sgt. Shaffer attended Defensive Tactics Instruction training.

PTPD administered our written exam to 42 individuals interested in joining our agency. Oral interviews of the top 20 candidates from the written exam were also conducted.

Ofc. Snyder and Graf completed their required 2 days of training. They also received their yearly recertification as a K9 team from Keystone K9 as required by MPOETC. Ofc. Snyder and Graf also provided a demonstration at the Nittany Mall and attended a bark in the park night during a State College Spikes game. Graf was deployed to do a person track and vehicle sniff following a vehicle/foot pursuit in Ferguson Township and conducted a vehicle sniff for PSP.

Chief Jolley attended a meeting with SCASD to discuss construction of the new Middle School, a DV/Sexual Assault Task Force meeting, and the Centre County Chiefs meeting.
