*Note: Criminal Arrests are the number of people arrested, not the number of charges, counts or cases cleared. These include arrests made at the time of the incident as well as those filed after an extended investigation.*

## **Department Notes:**

- A 21-year-old female was arrested for access device fraud. The female used a stolen credit card to make over \$5,000 of purchases at several area stores.
- A 22-year-old male and a 23-year-old female were arrested for criminal mischief. The pair damaged property offered for sale in a township store as they attempted to change the price tag on an item.
- A 38-year-old male was arrested for false alarms to agencies of public safety, disorderly conduct, and public drunkenness. The male, who was heavily intoxicated, was creating a disturbance inside a township hotel. The male then proceeded to pull the fire alarm within the building.
- 4 arrests were made for retail theft and 1 arrest was made for DUI.
- Officers successfully served 6 warrants of the 11 warrants that they attempted to serve.
- Officers conducted 16 vacation home checks.

**Use of Force:** PTPD officers did use force during two incidents in the month of July.

PTPD officers were dispatched to assist Ferguson Township PD for an intoxicated and disorderly male in the parking lot of a Ferguson Township business. It was reported that the male had placed another patron in a choke hold prior to PD arrival. Officers encountered the male in the parking lot, and he was uncooperative. Officers attempted to verbally de-escalate the male but

were unsuccessful. As FTPD attempted to arrest the male he began to resist. PTPD officers assist by securing the male's arms and legs. FTPD charged the male. There were no injuries to officers. The male was transported to the hospital.

PTPD officers were dispatched to a township hotel for an intoxicated, disorderly male who had pulled a fire alarm. Officers made contact with the male in his room. The male was uncooperative and began to grow increasingly agitated. Officers employed several de-escalation techniques but were unsuccessful. The male refused to provide officers with his identification. As officers attempted to take the male into custody he began to resist. Officers had to control the male's arms while they struggled to get him handcuffed. Eventually the male was successfully handcuffed. There were no injuries reported, and the male was charged and arraigned.

### **Community Relations**

Ofc. Tuskovich participated in the Fourth Fest Parade.

Ofc. Snyder and Graf did a K9 demonstration for Girl's week at Camp Cadet.

Ofc. Finocchio conducted training for hotel staff from our township hotels to raise awareness for them to help identify criminal activity that might be occurring on their properties and when to involve law enforcement.

### **Training and Department Activities**

Sgt. Shaffer and Ofc. Tuskovich attended Tactical Response Team Training.

Ofc. Friend attended training on Vehicle Inspection Regulations.

Ofc. Vardzel attended training on Motorcycle Collision Investigations.

Ofc. Kauffman attended training on Advanced Law Enforcement Rapid Response Training and received his instructor's certificate.

Ofc. Snyder and Graf completed their required 2 days of training. In addition to training, they conducted a sniff for a PTPD case where Graf indicated on an envelope containing \$670 of US Currency and participated in a drug sweep at Cove Forge Rehabilitation Center.

Chief Jolley attended the Centre Region Emergency Services group meeting, a Big Brothers/Big Sisters advisory committee meeting, and assisted with interviews at the Bellefonte Police Department.

SUBJ: Performance Report

On 7/2/25, Ofc Soohoo and Ofc Friend responded to a residence in Patton Township for a report of an unresponsive male. The officers arrived and quickly determined that the patient was in the advanced stages of an opioid overdose. They administered a total of three doses of Naloxone to the patient. They also utilized a bag valve mask and oxygen to provide rescue breathing to the patient. The officers continued to assist EMS when they arrived and the patient eventually regained consciousness. He was transported to the hospital for more advanced care.

It was due to the quick actions of Ofc Soohoo and Ofc Friend that a patient who was suffering from a life threatening opioid overdose was revived to the point that he could be transported for further care. Their actions reflect the highest credit on themselves and the Patton Township Police Department.
