Note: Criminal Arrests are the number of people arrested, not the number of charges, counts or cases cleared. These include arrests made at the time of the incident as well as those filed after an extended investigation.

Department Notes:

- A 32-year-old male was arrested for criminal mischief. The male shot a pellet gun at the victim's truck causing damage including a broken mirror, window, and a flat tire.
- A 33-year-old male was arrested for endangering the welfare of a child. The male headbutted a door while holding his small child. The incident was captured on camera.
- A 50-year-old male was arrested for invasion of privacy. While searching the male's phone from a related incident, officers found evidence that he recorded a female, who was naked, inside her residence without her consent. The male was standing outside her residence when he made the recording.
- 8 arrests were made for retail theft, and 4 arrests were made for DUI.
- Officers successfully served 6 warrants of the 12 warrants that they attempted to serve.
- Officers conducted 6 vacation home checks.

Use of Force: PTPD officers did use force during one incident in the month of August.

PTPD officers went to serve an arrest warrant related to a stalking and harassment incident. Officers were advised that the subject of the warrant brandished a knife during his last interaction with law enforcement. Officers were able to talk the male into exiting his residence

without any weapons. Officers controlled his hands and arms, and the male was taken into custody without incident. There were no injuries reported as a result of this incident.

Community Relations

Ofc. Finochio attended National Night Out hosted by Spring Township Police Department.

Ofc. Tuskovich attended State College Area School District's opening day assembly for staff. He also did an in-service safety presentation at Park Forest Middle School.

Sgt. Shupenko gave a bike safety presentation and participated in a bike rodeo for Boy Scout Troop 375.

Ofc. Tuskovich provided active shooter training for the staff at Penn Highlands Hospital. He also presented this training to members of the Alpha Fire Police.

Ofc. Vardzel conducted a free Child Safety Seat Installation and Inspection event at the ABC Children's Center.

Ofc. Tuskovich provided a safety and security presentation for State College Area School District's transportation department.

Ofc. Tuskovich and Chief Jolley participated in the parade at the Centre County Grange Fair.

Training and Department Activities

Sgt. Shaffer and Ofc. Tuskovich attended Tactical Response Team Training.

Det. Sallade attended Understanding & Supporting Commercially Sexually Exploited Children training.

Ofc. Kauffman attended a Traffic Safety Conference.


Det. Sallade attended Trauma Notification training.

Ofc. Brooks participated in a joint criminal interdiction detail with the Pennsylvania State Police. Ofc. Brooks and a PSP Trooper stopped a vehicle on Interstate 80, in Benner Township. The vehicle operator was nervous, and indicators of criminal activity were observed. A K9 team arrived at the stop and the dog hit on the car. Officers searched the car and located \$32,000 in US Currency inside a backpack in the trunk of the vehicle. The money was determined to be related to drug transactions.

Ofc. Snyder and Graf completed their required 2 days of training, and they participated in the Grange Fair Parade.

Chief Jolley attended two PSU football meetings, Emergency Vehicle Operation Course training, a Criminal Justice Advisory Board meeting, the Centre County Chiefs meeting, and the Community and Campus in Unity meeting.

On behalf of Spring Township Police Department, I want to extend a heartfelt thank you for attending our National Night Out event on August 5th, 2025



SUBJ: Performance Report

On 8/4/25, Ferguson Township police received a report of a juvenile male who was found hanging from a rope in his bedroom. No Ferguson Township police officer was able to respond so they requested assistance from Patton Township. Ofc Brooks, Ofc Brahosky, and Ofc Kauffman immediately responded to the residence and found family members attempting CPR on the patient, who had no pulse. Ofc Brooks attached an AED while Ofc Brahosky took over chest compressions. Ofc Kauffman conducted rescue breathing. The three officers continued CPR until EMS arrived and took over. The patient eventually regained a pulse. He was transported to the hospital for more advanced care.

It was due to the quick actions of Ofc Brooks, Ofc Brahosky, and Ofc Kauffman that a patient who was in cardiac arrest was revived to the point that he could be transported for further care. Their actions reflect the highest credit on themselves and the Patton Township Police Department.
