*Note: Criminal Arrests are the number of people arrested, not the number of charges, counts or cases cleared. These include arrests made at the time of the incident as well as those filed after an extended investigation.*

## **Department Notes:**

- A 28-year-old male was arrested for theft. The male was working overnight security when he removed \$3,000 worth of merchandise from the store he was working at.
- A 51-year-old male was arrested for theft by deception. The male made two fraudulent returns to himself, totaling \$272, while working in a township store.
- A 38-year-old male and a 34-year-old male were cited for trespassing. The males were hunting on property without permission from the owner. The property was properly posted with "No Trespassing" signs.
- 9 arrests were made for retail theft, and 3 arrests were made for DUI.
- Officers successfully served 10 warrants of the 14 warrants that they attempted to serve.
- Officers conducted 3 vacation home checks.

**Use of Force:** PTPD officers did use force during two incidents in the month of November.

An officer responded to a retail theft incident at a township store. The female suspect was uncooperative and refused to give the officer her purse. The officer pulled the purse from the female's hands and handcuffed her behind her back. A search of the purse revealed \$173 worth of stolen merchandise. There were no injuries reported and the female was processed for the retail theft arrest.

Officers were dispatched to assist FTPD with a trespass incident. An intoxicated male was refusing to leave a residence where he did not belong. The male resisted when officers attempted to take him into custody. Officers took the male to the ground where he continued to kick and resist. The officers were able to gain control of the male and handcuff him. Due to the level of the male's intoxication, EMS was summoned to the scene, and he was transported to the hospital. No injuries were reported and FTPD handled the criminal charges.

### **Community Relations**

### **Training and Department Activities**

Sgt. Shaffer and Ofc. Tuskovich attended Tactical Response Team Training.

Ofc. Snyder and Graf completed their required 2 days of training. Graf was deployed at the Greater Altoona Career and Technology Center and the Hollidaysburg Junior High School as part of his training. He also conducted sniffs of two vehicles.

Chief Jolley assisted with interviews at Bellefonte PD and attended an active attacker exercise hosted by Penn State which included stakeholders from all Centre County first responder agencies.
