Note: Criminal Arrests are the number of people arrested, not the number of charges, counts or cases cleared. These include arrests made at the time of the incident as well as those filed after an extended investigation.

Department Notes:

- A 32-year-old male was arrested for possession of a controlled substance and possessing drug paraphernalia. Officers were called to check the welfare of the male who was passed out in his vehicle. The officer noticed the illegal items in the vehicle. One of the substances was tested and found to be methamphetamine.
- A 28-year-old male was arrested for criminal trespass. The male entered an apartment that did not belong to him, took a shower, and used the washing machine.
- A 30-year-old male was arrested for fleeing/eluding law enforcement and flight to avoid apprehension. The male who had warrants out for his arrest failed to stop for an officer when they attempted to pull his vehicle over. Spike strips were eventually used to stop the vehicle. The male then fled on foot. Officers eventually located the male in another vehicle and were able to take him into custody.
- 19 arrests were made for retail theft and 1 arrest was made for driving under the influence.
- Officers successfully served 17 warrants of the 18 warrants that they attempted to serve.
- Officers conducted 21 vacation home checks.

Use of Force: PTPD officers used force during three incidents in the month of June 2022.

Officers responded to a residence for a report of a highly intoxicated female destroying things in the house. The woman's daughter was gathering belongings to leave. The mother continued to yell and attempted to push past officers to confront the daughter. Officers decided to handcuff the woman for the safety of everyone on scene. After a brief struggle, officers were able to handcuff the female and continue to deescalate the situation. No injuries were reported by the female or the officers.

Officers were dispatched to deal with the same female approximately 5 hours later. The female was experiencing a mental health crisis and she was attempting to assault her husband. Officers had to physically restrain the female who was attempting to charge at her husband. The female continued to push and attempt to push past officers on scene. Officers escorted the female inside the residence and attempted to verbally deescalate the situation. The female was eventually transported to the hospital on a 302 petition. No injuries were reported by the female or the officers.

Officers attempted to stop a vehicle where the driver/owner had warrants out for his arrest. The vehicle fled from officers. Eventually spike strips were used to stop the fleeing vehicle. Officers then conducted a felony stop, where they pointed their firearms at the suspect vehicle. The driver fled the stop on foot. A short time later the driver was located in another vehicle. Officers attempted to take the male into custody, but he refused to cooperate. He attempted to again flee on foot. An officer had control of his left arm and took him to the ground. Two officers controlled the male on the ground until other officers arrived, and they could successfully handcuff him. There were no injuries reported by the male or by the officers involved.
