## **Department Notes:**

- A 23-year-old male was arrested for possession of a small amount of marijuana and possession of drug paraphernalia. The male was trespassing at a residence when officers made contact with him. Officers noticed the male had a warrant via the Centre County Sheriff's Office. The officers located the drugs and paraphernalia as they took him into custody on the warrant.
- A 46-year-old male was arrested for theft by deception. The male put the exact same merchandise into two separate shopping carts in a township store. The male then paid for one of the carts and exited the store. A short time later the male reentered the store and "returned" the items in the second cart still inside the store. The male was refunded over \$200 dollars.
- A 23-year-old male was arrested for simple assault, false imprisonment, harassment, and criminal mischief. The charges stemmed from a domestic violence incident where the male physically refused to let a female leave a residence and damaged her vehicle.
- 8 arrests were made for retail theft and 1 arrest was made for driving under the influence.
- Officers successfully served 6 warrants of the 13 warrants that they attempted to serve.
- Officers conducted 3 vacation home checks.

**Use of Force:** PTPD officers used force during one incident in the month of August 2022. Officers were dispatched to a township store for a retail theft incident. Staff had already detained the suspect and as officers contacted him, he pulled away from them and fled on foot. Officers ran after the male and were able to grab onto his arms as he tried to enter a random vehicle in the parking lot. The male ignored commands to stop resisting and he continued to fight with officers. An officer deployed a taser striking the male on his back. The taser was effective and officers were able to get the male onto the ground and successfully handcuff him. Following our policy, EMS was summoned to evaluate the male and he was cleared without injury. Two officers suffered minor injuries as a result of the scuffle with the male. Officers found that the male ran because he had a warrant out for his arrest, and he was in possession of methamphetamine.
