*Note: Criminal Arrests are the number of people arrested, not the number of charges, counts or cases cleared. These include arrests made at the time of the incident as well as those filed after an extended investigation.*

## Department Notes:

- A 49-year-old male was arrested for access device fraud and theft. The male used his ex-girlfriend's checking account without her permission. He stole money from her account and deposited it into his Venmo account.
- A 18-year-old male was arrested for theft and receiving stolen property. The male observed a cordless drill unattended inside a township business. The male took the drill and left the scene. The male was later identified, but no longer had the drill. He was however in possession of a drill bit, and he confessed to taking the drill from the business.
- A 24-year-old female was arrested for possession of crack cocaine, methamphetamine, and paraphernalia. The female was riding in a vehicle that was detained by officers investigating a retail theft incident. Officers served a search warrant on the vehicle and recovered the illegal items.
- 16 arrests were made for retail theft, 32 arrests were made for minor's law, and 4 arrests were made for driving under the influence.
- Officers successfully served 7 warrants of the 17 warrants that they attempted to serve.
- Officers conducted 8 vacation home checks.

**Use of Force:** PTPD officers used force during two incidents in March.

The first incident occurred as PTPD officers were assisting FTPD officers on a father/son Domestic Dispute incident. The son had assaulted his father and as officers attempted to take him into custody, he began to resist arrest. A PTPD officer pinned the sons left arm down while another PTPD officer secured his legs. Two FTPD officers were able to handcuff the individual. No injuries were reported.

The second incident also occurred as PTPD officers were assisting FTPD officers on a PFA violation arrest. The male who was already handcuffed refused to get into a FTPD cruiser. A PTPD officer pulled the male by his shoulder into the vehicle as a FTPD officer guided him in from outside their vehicle. No injuries were reported.

### **Community Relations:**

Officers conducted multiple walk throughs at The Centre Indoor Sports Complex for various basketball tournaments held there throughout the month.

Ofc. Tuskovich spoke to 6th grade academic literacy classes at Park Forest Middle School about how police evaluate evidence.

Ofc. Tuskovich and Det. Federinko spoke to 8<sup>th</sup> grade PFMS students about their jobs for law day.
