Note: Criminal Arrests are the number of people arrested, not the number of charges, counts or cases cleared. These include arrests made at the time of the incident as well as those filed after an extended investigation.

Department Notes:

- A 37-year-old male was arrested for possession and delivery of narcotics. The male was selling methamphetamine around the Centre Region. When he was arrested, he was in possession of meth, a large amount of money, and drug paraphernalia.
- A 49-year-old male was arrested for burglary, theft, and person not to possess a firearm. An officer investigated a complaint of a stolen package from a residence. The officer secured a search warrant for the suspects residence and recovered the stolen package, a stolen firearm, and located other property that had been reported stolen. Through interviews, the officer tied the suspect to a previously reported burglary at a residence nearby.
- 13 arrests were made for retail theft, 25 arrests were made for minor's law, and 6 arrests were made for driving under the influence.
- Officers successfully served 3 warrants of the 12 warrants that they attempted to serve.
- Officers conducted 11 vacation home checks.

Use of Force: PTPD officers did not use force during any incidents in February.

Community Relations:

Ofc. McElrath participated in the opening ceremonies for the Special Olympics. He also assisted by distributing medals to the athletes.

Officers provided a police presence and walked through the first annual Happy Valley Comic and Collectable Convention held at The Centre Indoor Sports Complex.

Ofc. Tuskovich spoke to the 7th and 8th grade health classes at Park Forest Middle School about drugs and alcohol.

Training and Department Activities

Ofc. Shaffer and Ofc. Tuskovich attended Tactical Response Team training.


Det. Federinko attended cell phone and computer forensics training.

On February 1, 2023 Ofc Vardzel responded to a residence in Patton Township for a theft of a package from the victim's porch. The victim provided camera footage of the suspect and Ofc Vardzel immediately identified the suspect from a prior interaction. Ofc Vardzel compiled a search warrant for the suspect's residence and recovered the stolen items. While executing the search warrant, Ofc Vardzel noticed additional suspected stolen items. Ofc Vardzel continued his investigation and learned that the suspect also likely possessed stolen firearms and had committed previous burglaries. Ofc Vardzel executed an additional search warrant and recovered stolen firearms. Through interviews he was able tie the suspect to a previously reported burglary. The suspect was ultimately charged with numerous counts of burglary, criminal trespass, theft, and firearms violations.

It was due to the diligent investigation of Ofc Vardzel that an individual whose actions were a detriment to the safety and well-being of the community was apprehended. His actions reflect the highest credit on himself and the Patton Township Police Department.

Dear Police Chief Tyler Jolley, Police Chief John Petrick, CentreLifeLink Director Scott Rawson and EMS Chief Kent Knable,

On January 19th, at approximately 1:15 pm, my husband, Bob, collapsed in our home while we were taking care of our grandson. I immediately called 911 and within a few minutes, the very First Responder was Patton Township Police Officer Bradley Tuskovich. As I was trying to get my husband shifted from his side to his back, to try and start CPR myself with our grandson in my arms, Officer Tuskovich bounded up our flight of stairs, and very calmly said, "Ma'am, it's ok, I've got this."

Truer words have never been spoken. He immediately began manual CPR. We believe that it was Officer Tuskovich's unbelievably fast response and his CPR efforts that were the first essential key to saving Bob both physically and mentally. In another two minutes, a host of other highly skilled professionals named below- Patton Township and Ferguson Township police officers, Centre LifeLink Doctor, paramedics, and EMT personnel arrived with oxygen, more equipment and they all worked together tirelessly to save him.

He had suffered a sudden cardiac arrest. They never gave up on him. They kept working together, so professionally doing manual CPR, giving him oxygen, the LUCAS machine and so much more for what seemed a lifetime to me. However, after being defibrillated five times, they finally had Bob's pulse. They didn't give up.

They each know what they did but - what we want to make sure they know is - ONE week later, he came home on Thursday, January 26th!! Didn't need to go to rehab. Walking independently within a few days. Going up and down stairs. Mentally sound - remembering his family and friends, experiences in detail, making jokes- back to the man we know and love. And best of all-- attached is a picture of him attending our daughter's baby shower this past weekend here in State College!!

They gave me back my beloved husband of 42 years. We have four adult children. We have seven grandchildren with another one on the way. He's from a large family of nine siblings, I have one sibling and we are fortunate to have many loving friends and neighbors. These amazing people through their selfless, hardworking actions saved all of us from a huge loss. We thank them for the nine broken ribs due to CPR being doing correctly. We thank them all from the bottom of our hearts.

Many years ago when our kids were small, we gave them a 'safe word' code 'beyond all measure' which has become an endearment forever in our family. So now for these tremendous professionals- first responders, police officers, paramedics, EMT's, doctors, trauma and ICU nurses and a host of other medical personnel - we thank them 'Beyond All Measure.' We also ask that these fine people be considered for awards, promotions, whatever is deemed appropriate. They are truly the best!

This is truly the best Valentine's Day ever!
