Note: Criminal Arrests are the number of people arrested, not the number of charges, counts or cases cleared. These include arrests made at the time of the incident as well as those filed after an extended investigation.

Department Notes:

- A 47-year-old male was arrested for theft by deception. The male purchased \$320.00 worth of merchandise from a township store and loaded it in his vehicle. He then returned to the store where he had staged a shopping cart with duplicate merchandise of what he had just purchased. He deceptively returned the duplicate property for a fraudulent refund.
- A 46-year-old male was arrested for theft. The male stole a purse from a shopping cart in a township store. The loss prevention worker noticed the theft and alerted officers. Officers engaged in a short foot pursuit with the male, ultimately taking him into custody and recovering the stolen purse.
- A 24-year-old male was arrested for burglary, terroristic threats, and harassment. The male broke into an ex-girlfriend's apartment where he threatened and physically assaulted her.
- 18 arrests were made for retail theft, 31 arrests were made for minor's law, and 4 arrests were made for driving under the influence.
- Officers successfully served 27 warrants of the 87 warrants that they attempted to serve.
- Officers conducted 6 vacation home checks.

Use of Force: PTPD officers used force during one incident in April.

Officers responded to a residence where a juvenile male was “out of control.” Officers held the juvenile in a seated position until he calmed down. When the juvenile was calm, officers were able to physically release him and speak with him about what had made him so upset.

Community Relations:

Ofc. Snyder attended a drug takeback event held at Wegmans. 27 pounds of unused and unwanted medications were collected.

Ofc. Tuskovich provided a tour of our station and a vehicle for the ARC of Centre County.

Sgt. Shupenko and Ofc. Vardzel each conducted ride alongs.

Ofc. Tuskovich attended Spikesfest at Medlar Field.

Ofc. Tuskovich spoke to Solid Foundation Educational Association (SFEA) elementary aged students at the Park Forest Baptist Church about Law Enforcement and the role of police officers.

Ofc. Tuskovich spoke to a 6th grade academic literacy class at PFMS about using evidence and reason to determine a conclusion.

Ofc. Tuskovich spoke to a girl scout troop about safety.

Ofc. Tuskovich went on recruiting trips to the IUP and Johnstown police academies.

Ofc. Shaffer gave a presentation about illegal drugs to the Islamic Society of Central PA. The main focus was teaching parents the signs that their children might be involved with drugs.

SUBJ: Performance Report

On 4/21/23, Ofc McElrath and Ofc Sunderland responded to a residence in Patton Township for a report of a 14 year old male attempting to hang himself. Ofc McElrath arrived first and quickly ascertained that the youth was inside a locked garage, standing on a stool, and with a belt around his neck that was attached to the garage door rail. Ofc McElrath attempted to engage in a dialogue with the youth but he was too distraught to communicate. When Ofc Sunderland arrived, Ofc McElrath succinctly informed him of an action plan which involved him kicking in the door and then picking up the youth while Ofc Sunderland removed the belt. The officers then immediately executed the plan and removed the youth from danger. Ofc McElrath then counseled the youth and later transported him to Mount Nittany Medical Center to be treated for abrasions to his neck and for a mental health examination.

It was due to the quick actions of Ofc McElrath and Ofc Sunderland that a life threatening suicide attempt was averted and that proper treatment was provided to a youth in crisis. Their actions reflect the highest credit on themselves and the Patton Township Police Department.
