*Note: Criminal Arrests are the number of people arrested, not the number of charges, counts or cases cleared. These include arrests made at the time of the incident as well as those filed after an extended investigation.*

### Department Notes:

- A 22-year-old male was arrested for identity theft, access device fraud, and attempted theft by deception. The male presented a fake identification and attempted to purchase \$3,500 worth of merchandise on a business account at a township store.
- Two 20-year-old males were arrested for underage drinking and fleeing law enforcement on foot. Both males were on a spin bike (one on the handlebars) traveling on N. Atherton St. An officer stopped them and as he was gathering their information they fled on foot. After a short foot pursuit one male was taken into custody. The other male was later identified and arrested.
- A 35-year-old male was arrested for simple assault and false imprisonment charges. The arrest stemmed from a domestic dispute between the male and his girlfriend.
- 6 arrests were made for retail theft, 34 for minor's law, and 8 for DUI.
- Officers successfully served 5 warrants of the 11 warrants that they attempted to serve.
- Officers conducted 22 vacation home checks.

**Use of Force:** PTPD officers used force during two incidents in the month of September.

The first incident occurred when a male was standing along a township roadway. Officers were concerned he might try to harm himself by entering traffic. After speaking to him for 30

minutes, officers tried to escort the male to a patrol car. He resisted and officers had to use force to overcome the resistance and secure the individual. EMS was summoned and the male was transported to the hospital. No injuries were reported.

The second incident, mentioned in department notes, involved a short foot pursuit. While running away from an officer, a male tripped and fell to the ground. The officer handcuffed the male without further incident. No injuries were reported.

### **Community Relations:**

Ofc. Tuskovich participated in the Park Forest Baptist Church Community Festival.

Ofc. Tuskovich presented to the Citizen's Police Academy about the Tactical Response Team.

Ofc. Tuskovich spoke with 6 grade students at Park Forest Middle School about social media usage and safety.

Sgt. Albright provided a police presence/traffic control at the Circleville Park for a 5K run/walk.

Ofc. Tuskovich, Ofc. Vardzel, Ofc. Shaffer, and Chief Jolley all participated in the 21<sup>st</sup> annual Children's Safety Fair. The event was a huge success and was very well attended! Kudos to Ofc. Tuskovich for organizing the event and to the Happy Valley Business Association (especially President, Matt Knaby) for their ongoing support and assistance with the safety fair!!

### **Training and Department Activities**

Ofc. Shaffer and Ofc. Tuskovich attended Tactical Response Team training.

Ofc. Shaffer and Ofc. Sallade attended Law Enforcement Compassion Fatigue training. Compassion fatigue can cause law enforcement personnel to shut down mentally, physically, and emotionally.

Ofc. Shaffer and Ofc. Sallade attended Survivor's Guilt in Law Enforcement training. As LE officers are regularly exposed to loss, death, and grief in their work, survivor's guilt is a normal reaction to surviving a life-threatening trauma when someone else does not.


Ofc. McCaslin attended a traffic safety/DUI conference.

Dear friends at our Patton Township Police Force,

My wife and I live at the corner of Hampton Court and the Cricklewood Raceway.

We are delighted to hear your police car sirens today, along our Cricklewood Raceway. I hope you caught many racing cars on our street.

We have lived here since 1998, and the vehicle traffic seems to travel faster every year! I was once one of the daily walkers along Cricklewood Raceway and Toftrees Avenue until it became too dangerous for me to do so.

Our township tried to slow traffic with speed humps, but the local speeders complained about them. And now we are trying to use yellow poles sticking up between the lanes. Maybe we ought to dig potholes or refuse to repair the roadway surface, which may or may not slow down traffic.

I drive my old white Buick within the speed limit. But I often have cars so near my back bumper. And sometimes they honk their horns for me to get out of their way. But I stay under the speed limit because there are children getting on/off their school busses, and daily joggers and adult walkers walking to the side of our streets 24-hours per day!

At 5:15 a.m. Monday, Wednesday and Fridays I drive my wife from our home to the DaVita kidney center for her necessary kidney dialysis. I sometime encounter walkers and joggers out getting their exercise at that early hour. They almost always carry a bright flashlight with them, so that I can easily see them from afar. Vehicle traffic picks up speed and volume around 6 a.m. when I gladly arrive back home.

I know you officers can't be everywhere at the same time. It just frustrates me that we cannot seem to enforce our traffic laws.

I had an idea which I think may work: Close the entry/exit at the intersection of Fox Hollow Road and Cricklewood, so that only police and fire engines and ambulances can enter/exit our neighborhood. Or, we may become a gated community with a guard on duty. But this is America, the land of the free . . . Well, these are nice thoughts but nothing more.

Thank you allowing me to vent my frustrations!



SUBJ: Performance Report

On 9/9/23 Ofc Sunderland and Ofc Soohoo responded to an address on Ghaner Rd for a domestic dispute. While enroute to the residence the officers were informed that a male and female were arguing and that the male threatened to shoot himself. It was also reported that the male had firearms in the residence. As the officers arrived they observed the female in her car in the driveway with the male reaching inside at her and kicking the car. The male then walked quickly back towards the residence. The officers immediately approached and Ofc Sunderland quickly engaged the male in a verbal conversation and persuaded him to leave the doorway of the residence and walk to them, where they safely took him into custody and calmed him down. A firearm was located just inside the entrance of the residence. The officers ensured that the male was taken to the hospital for a mental health evaluation.

It was due to the quick actions of Ofc Sunderland and Ofc Soohoo that a volatile and dangerous situation was quickly brought under control and an individual in crisis was provided with treatment. Their actions reflect the highest credit on themselves and the Patton Township Police Department.

SUBJ: Performance Report

On 9/15/23 Ofc. Sallade and Sgt. Shupenko responded to an address on Park Forest Ave. for a report of a one-year-old male in cardiac arrest. Ofc. Sallade arrived first and grabbed her AED as she rushed into the home. Ofc. Sallade found the mother holding her motionless son. She took the child and immediately began providing aid. Ofc. Sallade determined that the child's airway was compromised and might be choking on something. She gave the child back blows and chest compressions. Ofc. Sallade was able to locate a pulse on the child and continued to administer back blows until the child began to cry. Sgt. Shupenko arrived on scene and officers reassessed the child by rechecking his airway and swiping his mouth for any obstructions. Officers then monitored the child until more advanced medical care arrived. The child was breathing and had a pulse as he was taken to the hospital for further treatment.

It was due to the quick actions of Ofc. Sallade and Sgt. Shupenko that a child unable to breathe on his own was stabilized on scene until he could be transported to more advanced medical care. Their actions reflect the highest credit on themselves and the Patton Township Police Department.
