Note: Criminal Arrests are the number of people arrested, not the number of charges, counts or cases cleared. These include arrests made at the time of the incident as well as those filed after an extended investigation.

Department Notes:

- A 45-year-old male was arrested for disorderly conduct and resisting arrest. The male was found laying along N. Atherton St. An officer checked on the male who immediately became combative and began attempting to physically fight with the officer. The male then began to run into traffic.
- A 38-year-old male was arrested for bad checks. The male wrote a check for almost \$10,000.00 from an account that had insufficient funds. The male failed to properly compensate the business when given the opportunity by police.
- A 44-year-old male was arrested for strangulation and harassment. The charges stemmed from a domestic dispute between the male and his wife.
- 5 arrests were made for retail theft, 14 for minor's law, and 3 for DUI.
- Officers successfully served 2 warrants of the 3 warrants that they attempted to serve.
- Officers conducted 39 vacation home checks.

Use of Force: PTPD officers used force during one incident in the month of October.

Officers were dispatched to a report of a male laying along N. Atherton St. The male became combative as officers attempted to provide him assistance. The male became a danger to

himself and others as he began to enter the roadway. Officers grabbed the male by his arms and lowered him to the ground. On the ground the male continued to resist but officers were able to handcuff him behind his back. The male was arraigned on charges of disorderly conduct and resisting arrest and placed in the Centre County Jail. No injuries were reported by the male, or the officers involved.






